Paul woke up at 6:00 AM; showered; ate breakfast; read the paper; and waited. At 8:00 AM he noticed a blue glow forming in the den. Nick Sawyer stepped-out of the glow.

"So, you finally caught me in the act."

"What the hell is that smell?"

"Ozone. It occurs as a result of the electrical charge dissipated when I materialize. It's harmless, really. It just smells quite horribly."

Paul noticed for the first time that Nick was carrying two rather large suitcases.

"I hope you're not planning to stay."

Nick emitted what sounded like a snort. "Would'nt dream of it. Just brought along some tools of the trade. You'll be needing these shortly, and they'll help explain some of the questions you asked yesterday."

Nick walked over to Paul's desk and placed the larger of the two suitcases upon it. He opened the case and took out a device that looked like a small photocopier.

"This is a deed analyser. A deed is inserted on this flat surface and its molecular structure is displayed on the screen. Its element is also displayed on the lower right-hand portion of the screen."

Nick inserted the first gold sheet into the machine and flipped the "on" switch. An image appeared on the screen.

"This document is a forgery."

"How can you tell?"

"See the bonds between the separate molecules? Note how sharply defined they are? That' a dead giveaway. Let me put in this second document. See how some of the bonds appear to be fuzzy?
